### Minneapolis Welcomes the NCWSS December 1 - 4



### Welcome to Minneapolis

From 94 East (St. Paul, Wisconsin):

Follow 94W, stay in far right lane to the 11th Street exit. Take 11th Street to 2nd Avenue. Turn left at 2nd Avenue. Go past the convention center. Turn right at Nicollet Avenue. Hotel and parking ramp will be on your left.

### From 35W (South):

### **Weed Contest Farmer problems**

### **Undergrad 1 (plot 11)**

Farmer plants soybeans on 4 consecutive days from June 1-4. Coop sprays Sharpen on all 4 fields on June 6.

Answer: first field was emerged at time of spray and showed injury. Some open furrows may have increased injury. Farmer should replant ASAP.

### **Undergrad 2 (plot 13)**

Corn showing injury (dead heart). This was the last corn field planted. Farmer sprayed glyphosate post after spraying soybeans.

Answer: tank was contaminated with Select, following spraying glyphosate+Select on soybeans. Farmer can replant soybeans (if other products applied to corn allow).

### <u>Undergrad 3 (plot 14)</u>

Soybeans showing bleach symptom on edge of field (next to neighbor's corn).

Answer: drift of Callisto onto the soybeans. Farmer should let the soybeans grow out of it and have conversation with neighbor regarding spraying in wind, etc.

### **Undergrad 4 (plot 18)**

Corn planted late May. Farmer sprayed with Roundup at 22 oz/a. Field is 100 acres and 20 acres showed injury. Farmer sprayed Flexstar GT on soybeans prior to this.

Answer: first load showed injury due to Flexstar contamination. Corn should recover.

### <u>Undergrad run-off (plot 10)</u>

Field in central Missouri not planted due to wet conditions. Date is July 1. Weeds very large. Answer: mow large weeds, then burn down with herbicide. Tillage not allowed. Plant soybeans as soon as possible.

### **Grad 1 (plot 15)**

Corn showing bleaching symptoms. Farmer was concerned about cutworms.

Answer: farmer sprayed Callisto + Lorsban, which is off label. Lorsban inhibits detoxification of mesotrione, causing injury. Corn should recover.

### **Grad 2 (plot 16)**

Corn showing variable stand and growth. Prowl + atrazine applied preemergence.

Answer: corn planted too shallow. May have been compounded by Prowl damage to roots. Can't re-

plant corn due to Prowl. Can't replant soybeans due to atrazine. Let plot produce what it can. Recommend planter adjustments, etc next year.

### **Grad 3 (plot 17)**

Bleaching symptoms on corn. Reflex applied last year. Balance applied about 10 days after planting. Answer: corn was emerged and Balance Pro cannot be used on emerged corn. Balance Flexx has the safener and can be used until V2. Corn will probably grow out of it.

### Grad 4 (plot 9)


Location is in North Dakota. Flexstar GT applied at 3.5 pt/a on large weeds. Soybeans showing burn injury. Carryover concerns for 2015 because of high rate. Will weeds die?

Answer: monitor regrowth of weeds and retreat if necessary. Soybeans will outgrow the injury.

### **Grad runoff (plot 19)**

Sorghum with large weeds. No pre herbicide applied. Location is Kansas.

Answer: Spray 2,4-D+atrazine ASAP. For next year (to be fallow), apply fall burndown if necessary and spring burndown in 2015. In future always spray pre on sorghum.
