Minutes of Sep 2021 NCWSS Board of Directors Meeting

President-Elect/ Program Chair - David Simpson

Discussion:

- David Simpson and other members of the Local Arrangement Committee visited the Amway Grand Plaza hotel to view the meeting venue
- ➤ Title submission for the 2021 NCWSS meeting ended Friday, September 18, 2021. Abstract site http://weedscimeetingabstracts.com
- ➤ The society's award luncheon will be on Wednesday (Dec 15) due to space logistics. Distinguished service award recipients and new fellows will be announced.
- Currently no local, state or federal Covid restriction on space use, social distancing or masks. The hotel is requiring employees to wear mask
- Restaurants could be a limiting factor as not all hotel restaurants are re-opened. Breakfast option: Starbucks or The Kitchen Counter. If Rendezvous is not open by meeting, may need to consider some other options.
- Lunch on Tuesday would be a concern. We can work with hotel to consider a "pop up" lunch option on Tuesday
- Sky walk provides option for getting around in winter
- Room block is 645 room nights with current commitment to fill 80% with NCWSS responsible for liquidation damages for the difference if usage falls below 80%. Hotel seems amenable to negotiating down from the 80%.

Action: Kelley will contact Tina and Mark and they will contact Amway Grand Plaza hotel to negotiate the contract to reduce the minimum room bock requirement.

- Sponsored Events: NCWSS President Reception; BASF committed to sponsoring Grad Student Mixer; Corteva anticipated sponsoring Grad Student Luncheon; NCWSS Society Mixer.
- Presentation by graduate students is down due to Covid; Travel restrictions for industry likely to reduce attendees. Could see 30%-40% reduction. Most industry will let their employees to attend NCWSS if they are presenting a paper/poster or a member of committee/chair of the section.

Motion: Harlene proposed a motion to precede with in-person NCWSS annual meeting to be held in Dec 2021. Motion passed with all in favor.
