## **Old Business**

## Update on 2023 NCWSS annual meeting (Dawn Refsell):

- General: A total of 170 titles received (48 MS; 48 PhD; 9 Undergrad students) + 5 grad students pending with late submit request., so the total number of presentations for the 2023 NCWSS annual meeting will be about 175.
- Student Contest numbers:
  - MS Students: 24 papers, 17 posters, 6 videos.
  - PhD Students: 20 papers, 25 posters, 1 video.
  - Undergraduate Students: 9 posters.
- Speaker for the opening remarks during 2023 annual meeting in Minneapolis is confirmed: Tom Peterson, Minnesota Department of Agriculture.
- Speaker for the society breakfast presentation is confirmed: Dustyn Sawall (Chemist, United Winfield) will speak regarding formulation technology and advancements.
- Symposia during 2023 NCWSS annual meeting:
  - Extension Video Preparation Symposia
  - Networking and Mentoring Symposia (Monday afternoon for students).
  - Symposia will be followed by a joint panel discussion. Student Mixtures.
- Some NCWSS committee meetings will be on Monday evening followed by BASF Quiz Bowl
  - a. Student contests/videos: 8 total videos.
  - b. Registration: 26 total registered for NCWSS annual meeting as of Sep 22, 2023.

#### **New Business**

MOP wording concerning Executive Board members and Fellow Committee members for being nominators or authors of support letters for distinguished achievement awards (DAA) nominees and NCWSS Fellows.

- Based on NCWSS MOP, there is an inconsistency in a guideline for support letters between distinguished achievement awards (DAA) and NCWSS Fellows, particularly for the NCWSS Executive Committee Members. As per current guideline "NCWSS Executive Committee members are not eligible to write a letter of support for the DAA nominees but can write a support letter for the NCWSS Fellow nominees.
- A motion was proposed to adjust this inconsistency about support letters that will provide an opportunity to NCWSS Executive Committee members to write support letters for the DAA nominees and Fellow nominees. Some sentences were adjusted in the NCWSS MOP. *Members of the Awards and Executive Committees are not eligible to write supporting letters for the DAA nominees.*
- A motion was approved with all in favor.
- Action: Amit will update the NCWSS MOP. It will be effective from next year as a call for DAA and Fellow awards is already out.

## Joint meeting of NCWSS and Northeast Weed Science Society (NEWSS) in 2026 (Reid Smeda).

- NEWSS: Strong on Horticulture crops and limited on Agronomic crops, so a joint meeting will complement program areas and attendees.
- NEWSS is flexible for the timing of the meeting and venue such as Columbus, OH.
- Dawn suggested having a conversation with the program chair and site selection committee (Eric, Kelley).
- Motion: To discuss a joint meeting of NCWSS and NEWSS in 2026.
- Motion passed with all in favor.
- Action: President Smeda will follow up with the NEWSS BoD for further discussion about program, awards, student activities, etc.
- Kelley will discuss with Mark and Tina about the negotiation of the venue possibly for Columbus, OH.

Next NCWSS BoD meeting is scheduled at 10 am on Dec 11, 2023 in Minneapolis. This will be an in-person meeting; however, Amit will send a Zoom invite, so if a BoD member is not attending NCWSS meeting should be able to join.
