Date of Preparation: July 24, 2017

#### Officer/committee Activities during the Year:

I am currently working on NCWSS program. On March 21, 2017 I met with Greg Elmore (local arrangements chair), Tara Steinke, and Greg Dahl at the Hyatt Regency St. Louis At The Arch to view meeting venue and talk about changes to the NCWSS program. The meeting space will be excellent. The last NCWSS meeting at this hotel was in 2012. The St. Louis Arch and museum is currently undergoing renovations. Greg Elmore is looking into finding a keynote speaker to talk about the Lewis and Clark Expedition and the characterization of new plants. I would like to include a presentation on the Herbicide Resistance Listening Sessions from 2016-2017 – possibly Jill Schroeder.

- One possible idea to free up more time for graduate and undergraduate student paper and poster contest judging. Allow for judging through Wednesday noon prior to NCWSS Awards Luncheon, present paper and poster awards at Society Social (Wednesday night).
- Finalizing symposia:
  - Equipment and Application Technologies Symposia Ryan Edwards will lead Data management and record keeping (needs a title)
  - Still looking at a couple of other possible symposia and organizers
    - Ideas:
      - Review of the first year of widespread use of new herbicideresistance technologies – Extension & Weed Biology, Ecology and Management Section
      - Endangered Species Act, Litigation, and EPA Registrations
      - Herbicide Resistance Management Plans

On July 21, 2017 Tara and I had a conference call with David Krueger on setting up NCWSS Title submission site. We went through how to set this up. There are a couple of questions for the board prior to getting this site up and running.

#### Questions for board:

- 1) Do we still need key words for abstract submission? (Board Recommendation is to delete)
- 2) Would it be possible to open the NCWSS site the second week of August for prepopulating authors in title submission? (see WSSA proposal below)
- 3) Do we want to continue with recording presentations? (Board agreed not to record in 2017)
  - 215 total views of 2107 presentations (193 unique views)
  - Web traffic for presentations: Jan. 119 views; Feb. 25 views; Mar. 47 views; Apr. 15 views; May July 9 views.
- 4) Do we want to consider moving the "What's new in Industry" to after the Industry Symposia Breakfast? (Syngenta is willing to pay of graduate students)
- 5) We received positive verbal feedback on the GuideBook App. Do we want to continue with this app for the 2017 NCWSS Meeting? (Board agreed that this should be standard cost of Meeting. Need to look at moving responsibility for loading docs to communications)

Monsanto is planning on hosting a Graduate Student Tour on Monday, Dec. 4 prior to the NCWSS Annual Meeting.

#### Points of discussion:

WSSA has voted to update their database with Apex WebStudio (David Krueger) for \$3000

- This allows for the import of member lists with profile information (affiliation, city, etc) in popup for title submission
  - Changes the title/abstract webpage such that co-authors are entered on a separate popup form.
  - When someone logs in, it displays their profile information first thing, and requires that they confirm that it is accurate.
  - There will be additional updates that will be needed for the reports as a result of these updates

WSSA is asking the four Regional Societies (NCWSS, WSWS, SWSS, and NEWSS) to split the cost to:

- Increase the size of the powerpoint slides that can be uploaded = \$500
- Add ability to enter Major Professor name for student contest submissions = \$500
- Add report for graduate student contests = \$1000

#### **Executive Secretary Report – Tara Stienke**

Date of Preparation: July 13, 2017

#### **Executive Secretary Report for Summer 2015 Board Meeting:**

The transition from Phil and Marathon Ag, to IMI has been completed. Phil continues to be a great resource and answer many questions.

<u>Finances</u>: The attached forms detail our financial position as well as our financial activities. Our fiscal year ends on November 30. All financial records have been transitioned to QuickBooks. NCWSS has a net worth of \$438,783.01, which is \$3261.35 more than at this time last year. We have \$31,712.81 in checking and \$83,259.72 in our money market (earning 0.3% interest). That is a total of \$114,972.53 in liquid assets. We have 5 CD's which will come due each year and be rolled over into 5 year CD's in the ladder system that the Finance Committee set forth in 2014. The Director of Science Policy support will come out this month (July 2017) for \$7,779.00. The remaining \$7500.00 for the Weeds Contest will also come out this month or next.

Stan Cooper with RBC has given the following report and suggests for our investment accounts:

31.56% Market short hedge

#### Recommended changes:

I would like to reduce the exposure to bonds by selling the two lowest yielding positions, FPA and Pimco Low Duration, and sell the Marketfield hedge position and then use the proceeds of these sales to buy four different global and international funds. My thinking is that the account is under exposed to growth investments and the most recent research is indicating the best values are in the international markets.

<u>Annual Meeting</u>: I have been working with the Program Chair and Local Arrangements Committee in preparation for our Annual Meeting in St. Louis. We set the registration fees for the 2017 Annual Meeting at the 2016 Board of Directors Meeting. The registration fees are as follows: \$275.00 for regular members, \$130.00 for students, \$170.00 for Honorary Members and Fellows. The website is set to open on August 1, 2017 (see discussion questions below). The industry breakfast will be \$45.00 per person this year. Stott Howard donated for students to attend the Industry Breakfast and we have \$2925.00 of that left for

2017 students (this would cover the cost of 65 students to attend the breakfast). I spoke with Stott and he told me that if there are more than 65 students that wish to attend, he will be happy to cover them as well.

<u>Other Activities</u>: I am working with Joe Wuerffel chair of the Industry Committee on the Sustaining Members.

#### Officer/committee Activities during the Year:


#### Officer/committee Activities during the Year:



How many years have you been a member of the North Central Weed Science Society (NCWSS)?




### What degree program are you currently in? (46 responses)



## What is your weed science research focus for your degree program? (Select all that apply)








# In your degree program, have you received Extension experience?




# How many years have you attended the NCWSS annual meeting?





## Have you competed in the Student Poster, Paper, and/or Video Contests? (Select all that apply)




How would you rate your overall Poster, Paper, and/or Video

student contest experience(s)?







# How would you rate the scientific discussions and presentations at the NCWSS annual meeting?




How would you rate the NCWSS annual meeting overall?




### Have you competed in the annual NCWSS Summer Weeds Contest?




### How would you rate the Weed ID Section of the Summer Weeds Contest?




### How would you rate the Unknown Herbicide Section of the Summer Weeds Contest?




How would you rate the Written Calibration Section of the Summer Weeds Contest?



How would you rate the Farmer Problem and Recommendation Section of the Summer Weeds Contest?




How would you rate the Team Sprayer Calibration Section of the Summer Weeds Contest?




Would you be interested in an addition to the summer Weeds Contest of a contest section regarding molecular / genetic weed science components?

Consistent ratings from judges. No blank comment sections from judges.

Have access to score sheet beforehand and get a copy of the results.

Video contest should be more announced to students participate more

Request judges to make specific comments (both good and bad) on their score sheets, I realize this is easier said than done, but sometimes I just get a sheet back with only a final score, no written comments.

Paper: requirements that will be graded in contest should be posted online. If you are attending the meeting for the first time you do not have access to that for example. Poster: posters should be held longer after contest so competitors have the chance to know more about other research and also share experiences. When you are in the contest is difficult to take a look at others. Video: more than one tv showing the video and it would be available during more time so everybody can watch. The winner should be announced together with other awards.

It would be nice if all judges explained their reasoning for particular scoring.

For the herbicide physiology section, there should be more of a distinction or maybe a separate category for more genetics-based presentations. I feel that this research is usually ignored simply because people aren't familiar with this material, but if there was a specific section that those who are interested could come and listen to students who are studying this area of Weed Science then the overall experience would be much more inviting for those students.

Make the Poster contest only in the mornings

Better quality poster board cut to sizes more accommodating for larger posters -2015,2016;

Every year, there seems to be some students that are supposed to be in the contest that either miss checking the box or their response is not recorded. For paper contests specifically, could there be a way to confirm that students are in the contest before the booklet is sent out. For instance, the chair of each section make sure participants from universities on Wednesday and Thursday are not wanting to be in the contest. I know this will add more time, but it would make planning each day more effectively.

That's a broad question. I wish the feedback was consistent. When one person gives me a 95 on my paper and someone else gives me 50 with no feedback or limited or just how they feel it should be done isn't very constructive.

For the paper and poster contest, do not divide the contest based on subject matter.

It would be nice if posters could stay up the entire week.

Make sure all the judges write out reasoning for scores and deductions and include constructive criticism on the score sheets. Will help us improve our presentation skills and know what to avoid.

I do not have any recommendations at this time.

Judges need not to evaluate the undergraduate poster contest so hard. Should provide constructive criticism instead of insults.

Having slightly different categories would be helpful. There is no category specific for genetic/molecular work in weeds or crops (herbicide physiology is normally as close as we get).

Submission information was a bit confusing. Some sort of syllabus of times and explanations would be useful

Most reviewers do not explain grades given in the contest.

Hello Tommy However (Now you know who wrote this my friend rsrs). So, the NCWSS must be focused on Extension actions too. For example, you guys should create a Extension paper presentations. Some kind of presentation able to show in a simple way complex things related to weed control. Then, students must be evaluated by your capacity to make information go easy, simple and with quality. Also, you should encourage

people to create new Projects for Extension actions. We have a great example with Prof. Kruger with you Moblie PAT LAB, but I'm sure that new great ideas could come together. Let's put the science on the field boys.

Poster: all students were supposed to be at all poster sessions, which meant we couldn't interact with other people with posters

Paper: evaluations were not very informative

Sometimes the posters are included in category that is different from the category they are present in.

Better sorting with judging groups (paper)
